New Business:

1. Set the 2010 Millage Rate and Adopt the 2010 Budget: Mr. Underwood discussed the presented package with the Board explaining that the package contains a budget Summary showing the budgets adopted for 2009 and the proposed budgets for 2010. These are budgets for the General fund, Juvenile Cost and Fee fund, Law Library, Confiscated Drug Fund, E-911, Drug Education, Jail, River North, Bradley Waterline, 2004 SPLOST, 1999 SPLOST, 2009 SPLOST,

2006 TE Grant, 2004 SPLOST Revenue Bond, Water and Sewer fund and Golf Course. Total of all these budgets amounts to \$23,712,465. He then called for a motion to adopt the resolution adopting these budgets for the fiscal year 2010.

Motion: Motion by Childs, second by Liston to adopt the resolution.

Vote: Adopted unanimously.

Mr. Underwood then asked for a motion to adopt the resolution establishing millage rates for 2009-2010 for Jones County – Unincorporated Area – 13.33, Incorporated Area – 14.72, Special Service Tax Districts-River North- 1.09, and Bradley – 3.25.

Motion: Motion by Gault, second by Childs to adopt.

Vote: Adopted unanimously.

2. Change date of the First Tuesday Meeting in October from October 6 to October 13, 2009 – Commissioners out of town at conference

Motion: Motion by Gault, second by Liston to move the October 6, 2009 Commissioner meeting to October 13, 2009.

Vote: Approved unanimously.

3. Approve commissioner travel to ACCG 2009 Fall Board of Managers Retreat – Saint Simons Island

Motion: Motion by Gault, second by Childs to approve.

Vote: Approved unanimously.
